PRAYER FOR DELIVERANCE

The objective is to expel any demons, close their avenues of access to the victim, and enable him/her to keep these avenues closed in the future. It is most effective to work as a team. One person is in charge, he or she does all the talking and, in steps 2, 6, 7 and 8, all the touching. Others pray silently and talk with the

leader quietly. Leadership can rotate during ministry. Steps 6 and 7 can be extremely painful. Don't hesitate to stop, provide comfort, and pray for healing. If the person can't remember important details or identify the cause of feelings, you can interrupt the ministry time and have him/her go home and ask the Holy Spirit.

1 GIVE THE INDIVIDUAL PRIORITY. Maintain a loving attitude. Be encouraging. Move to a quiet place if possible. Invite the Holy Spirit to be present

2 IF A SPIRIT MANIFESTS, MAKE IT BE QUIET.

Repeat "Submit in the name of Jesus!" Be persistent, this may take time. Only the leader touches the person.

3 ESTABLISH AND MAINTAIN COMMUNICATION WITH THE

PERSON.*
You must have his cooperation. "Joe, can you hear me? Look at me!"

4 ASK THE PERSON WHAT HE OR SHE WANTS FREEDOM FROM.

Make sure he or she really wants freedom from the bondage(s).

5 MAKE SURE THE PERSON HAS ACCEPTED JESUS AS LORD AND SAVIOR.*

If not, lead him/her in prayer for salvation. If you can't, bless him/her but don't try deliverance.

6 INTERVIEW THE PERSON TO DISCOVER THE EVENT(S) OR RELATIONSHIP(S) THAT HAVE LED TO THE BONDAGE(S).

Expose where forgiveness is required, and where healing, repentance and breaking of bondages are needed. Find all open doors. If there is no obvious place to start,

begin with his or her parental relationships, then move to other areas. Be thorough, don't rush. Do not stir up demons, keep them quiet. List the spirits encountered and areas requiring forgiveness of others or repentance. Consider a curse if the person has persistent difficulty in an area of life. Fear is an entry point for different spirits and a problem in many illnesses.

7 LEAD THE PERSON IN CLOSING THE DOOR(S) THROUGH WHICH THE SPIRIT(S) ENTERED.

(If there is no one to forgive, go to Steps B through D.) He or she should:

A.*Forgive whoever caused the hurt or led him or her into wrong conduct. Be specific, item-by-item. The seeker should release the offender to God, and commit to take his or her hands off - to not try to change the offender, and ask God to bless him or her in every way. If the seeker is unable to forgive, explain the scripture to him or her. You can quietly bind any spirit of unforgiveness. If he or she is still unable to forgive, pray for healing and blessing but not deliverance

B. Repent of his or her specific sins in the situation(s). "Father, forgive me for ____ (hate, bitterness, sharing my __, reading horoscopes, etc.)'

C Renounce audibly and firmly all spirits involved, in the name of Jesus. In the case of sex outside marriage, the person should renounce spirits taken in from every partner he or she can recall, individually by first names. Pacts with Satan and inner vows must be renounced and curses broken. "In the name of Jesus I renounce the spirits of ." "In the name of Jesus, I renounce the vow I made never/always to

D. Break the bondage(s) caused by the sin, attitude, conduct, vow, spirit, curse, etc., in the name of Jesus. This closes the door. (You or the seeker can do this.) "In the name of Jesus I break the power of the spirit(s) of _ (Tom) so that when they are cast out, they will not come back." "In the name of Jesus I break the power of every curse over (Tom) from ____(father's careless critical words, father's Freemasonry, etc.)"

8 CAST OUT THE UNCLEAN SPIRIT(S) IN THE NAME

Some people cast spirits out one-by-one, some cast them out by groups. Do what works for you. With all doors closed, the spirits will leave quickly and quietly.

If they don't leave promptly, go back to Step 6. Tell the person there may be other spirits to deal with. Reinterview. Ask the Holy Spirit to show you or the seeker or a team member what He wants to do next. He is very willing to help you!

9 HAVE THE PERSON THANK JESUS FOR HIS OR HER DELIVERANCE.

If he or she cannot, or if spirits manifest, more doors need to be closed. (Same for Step 10.)

10 HAVE THE PERSON ASK THE HOLY SPIRIT TO FILL HIM OR HER AND ALL THE PLACES FORMERLY OCCUPIED BY THE EVIL SPIRITS.

* Do not pray for deliverance without these items, because the person probably will not stay free. Just pray for his/her healing, and for blessing.

|PRAYER FOR HEALING|

1 INTERVIEW

- · What is your name?
- How can I pray for you?
- How long have you had this condition?
- · Do you know the cause?
- Why do you think you have this problem?

The purpose is to determine the root cause of the infirmity or sickness. Possible roots: an afflicting spirit; sickness rooted in the soul (psychosomatic); or natural causes such as accident, injury, or disease. Ask probing

2 PRAYER SELECTION

PETITION "Father, in Jesus' name I ask You to heal the inflammation in Joe's knee and take out the swelling and pain."

COMMAND "In the name of Jesus I command the inflammation in Joe's knee to be healed, and all swelling and pain to leave."

- · Do you have a doctor's diagnosis?
- Did someone cause this condition? Have you forgiven him or her? (Unforgiveness can be a major hindrance to healing.)
- Did any significant or traumatic event happen to you when (or within 6 months or a year before) this condition started? (Before praying for physical healing, you may need to help the person with unforgiveness, or with emotional wounds such as fear, shame, and rejection.)

Depend on the Holy Spirit-quietly ask Him if He has anything to show you about the condition or its cause. Listen to Him!

USE COMMANDS WHEN

- Breaking a curse or yow
- Casting out an afflicting spirit or other spirit
- You have used petition prayers and progress has stopped
- You are led by the Holy Spirit
- A word of knowledge or other circumstance indicates that God wants to heal the person immediately

3 PRAYER MINISTRY

- 1 Audibly ask the Holy Spirit to be present with His guidance and His healing power.
- 2 Ask the person not to pray but instead, to close his/ her eyes and focus on his/her body. It's a time for him/ her just to receive.

TIPS

- · Keep your eyes open, to see God's touch
- · Use short, specific prayers
- Try different kinds of prayer
- Be loving! Be persistent!
- Follow any leading of the Holy Spirit
- Always pray in the name of Jesus
- Don't preach or give advice

4 If indicated, have the person confess any sin

3 Ask him/her to interrupt for you and tell you if he/she

feels something: heat/electricity/trembling, etc. (About

50% of people being healed feel something).

- (unforgiveness, anger, etc) and/or pray for the person's emotional healing before praying for physical healing.
- If a specific prayer brings improvement, keep using it immediately
- Pray for symptoms and cause, if the cause is known
- · Periodically ask, "What is going on?"
- Remember: trust the Holy Spirit, not the method
- Thank God for whatever He does (You cannot thank God too much!)

4 STOP AND RE-INTERVIEW

Keep listening to the Holy Spirit and stop to re-interview. If pain moves around or increases during prayer or if a condition has existed a long time, consider casting out an afflicting spirit. If you are not making progress, consider interviewing the person further:

- Would you try again to remember any significant event?
- Have any other members of your family ever had this condition?
- Do you have a strong fear of anything?
- Has anyone ever pronounced a curse over you or vour family?

- · Do you know of anyone who is very angry at you?
- Have you ever participated in any kind of Satanic or other occult activity?
- Has anyone in your family been a member of the Freemasons?
- Have you had other accidents? (He or she may be accident-prone.)

STOP PRAYING WHEN

- The person: a) is healed or b) wants you to stop
- The Holy Spirit tells you to stop
- You are gaining no ground and receive no other way

5 POST PRAYER SUGGESTIONS

After praying, it is beneficial to give helpful follow-up instructions or exhortations.

- · Encourage the prayee from Scripture
- Share appropriate lifestyle changes for maintaining healing and to prevent problem re-occurrence
- If someone is not healed or is only partially healed, do not accuse the person of a lack of faith or of sin in his or her life as the cause
- Prepare the person to resist any further attack after healing



8-STEP HEALING PRAYER MODEL FOR POST-TRAUMATIC STRESS DISORDER

- 1. ASK Interview the person. What experience or action resulted in PTSD? If they are military, thank them for their service, remind them that their service has not been in vain, and welcome them home. Note: This is not a counseling session, nor do you want the person to unload all of their traumatic experiences.
- 2. **EXPLAIN** Tell the person what you will do and receive their permission to do it. Keep eye contact during prayer time. Ask for permission to either hold their hand or lay hands on them during prayer. Explain that you will be taking authority and commanding out all affects the mentioned experiences/actions have over their being.
- 3. **FORGIVE** Declare the forgiveness of God to them by the power of the blood of Jesus Christ. Ask them if there might be anything between themselves and God, and allow them to renounce any sin. Assist them in forgiving those who might have injured them.
- 4. **DECLARE** Welcome the presence of the Holy Spirit to fulfill the mission of Jesus according to Isaiah 61:1-3. Speak through declaration to break off any feelings of shame, guilt, condemnation, etc. for anything the person has done, been ordered to do, or have had done to them. Break off responsibility of their experiences/actions.
- 5. **CANCEL** Cancel through declaration prayer every assignment of the powers of darkness against the person's mind, body, and spirit that cause fear, anxiety, worry, etc. Command all afflicting and tormenting spirits of trauma associated with the experiences/actions to leave and never return. If the person experienced sexual assault/violation, sever every soul tie that was created and connects the person to the abuser.
- 6. **HEAL** Heal through declaration prayer the broken heart that was caused by traumatic experiences/actions. Destroy strongholds of thoughts and beliefs that have built up around these wounds, according to 2 Corinthians 10:3-5. Speak faith, trust, peace, and the promise of protection according to Psalm 91. Pray for traumatic images and memories to "dry up and die", and for the memory center to function normally. Heal through declaration prayer the physical healing over any wound or injury associated with the trauma and disconnect triggers of the five senses that bring back memories or images.
- 7. **PRAY** Pray that the Lord release the person from imprisonment or captivity associated with the experiences/actions. Speak healing over the systems of their bodies that have been affected, (nervous, endocrinal, muscular, immune). Declare freedom to the mind, body, and spirit. Ask the Holy Spirit for re-integration of their brain, restoring healthy connections.
- 8. **IDENTIFY** Declare that they are a royal son or daughter of a loving Father. Lead them through declarations of their identity in Christ according to 2 Corinthians 5:17, that their history no longer identifies them. Declare according to Proverbs 3:24 that God is giving them His promise of "sweet sleep", and they no longer will have fear. Speak healing and freedom from post traumatic stress. Their experiences/actions no longer have a hold over them. (See reverse for declaration prayer as ending to final step.)

What is Post Traumatic Stress Disorder?

Post-Traumatic Stress Disorder (PTSD) is an anxiety disorder that may develop after exposure to a terrifying event or ordeal in which a person experienced severe physical harm or was threatened with such harm. Traumatic events that may trigger PTSD include violent personal assaults, natural or unnatural disasters, accidents, or military combat. Anyone who has gone through a life-threatening event can develop PTSD including military troops who served in war; rescue workers for catastrophes like the 2001 terrorist attacks; survivors of accidents, rape, physical or sexual abuse, and other crimes; immigrants fleeing violence in their countries; survivors of earthquakes, floods, and hurricanes; and those who witness traumatic events. Family members of victims can develop the disorder as well. PTSD can be a crippling disorder, affecting the ability of the sufferer to live a normal, everyday life.

What are signs of PTSD?

-Becoming upset when reminded of traumatic experience/action
-Having nightmares, vivid memories, or flashbacks to the experience/action
-Feeling numb or losing interest in things the person used to care about
-Becoming depressed, anxious, jittery or irritable
-Thinking that you are always in danger and being "on alert" for potential threats
-Experiencing chronic nerve pain
-Having difficulty sleeping
-Having trouble keeping the mind focused on one thing
-Using alcohol or drugs to numb feelings
-Considering or actually harming yourself or others
-Pulling away from other people and becoming isolated

Step 8 Conclusion:

New Creation Declaration Blessing: This is who my Father says I am (Have the person receiving prayer repeat this)

I am a child of the King; I am a co-heir with Jesus. All Jesus bought and paid for is my inheritance. I am loved. I am forgiven. I am cleansed by the blood. I am accepted in the Beloved. I am filled with His Spirit. I have angels protecting me and assisting me in the ministry of Jesus. I am united with Jesus; I have been crucified with Christ. I died with Him. I was buried with Him. I was raised with Him. I am seated with Him in the heavenlies far above all rule, all power, all authority, and above every name that is named, not only in this age, but also in the one to come. Therefore, I carry the authority of Christ. I have authority over sickness, over sin, over demons, and over the world. I am the salt of the earth. I am the light of the world. All things work together for my good because I love God, and I am called according to His purpose, which is for me to be conformed to the image and likeness of Christ. I can do all things through Christ, because greater is He who is in me than he who is in the world.
